**Results:**

Trainings and races results will be published on the official notice board after each qualification training and race. The prints of the results will be available in the Race Office in boxes after the time for protest specified in regulations expires.

**Parc Fermé:**

Cars must remain in Parc Ferme from right after the race until the scrutineering team releases them. During cars' stay in Parc Ferme no work may be done at the car, unless it's done under supervision and order of the scrutineering team. Parc Fermé is located at the entrance to the karting track and is obligatory after each qualification session and race.

**Prize giving:**

The prize giving ceremony will be held after each race on the rostrum located near the Tower. First three drivers in each class after they place their cars in Parc Ferme shall go to the Organizer Van which will drive them to the prize giving near the Tower..

8. WPP – cars divided in classes according with the WPP Regulations 2010 /Art.1.10.2/

- Class 1 – up to 1150ccm (gr.N,A)
- Class 2 - above 1150ccm up to 1400ccm (gr.N,A)
- Class 3 - above 1400ccm up to 1600ccm ( gr.N,A)
- Class 4 - above 1600ccm up to 2000ccm (gr.N,A)
- Class 5 - above 2000ccm OPEN class (technical regulations of WPP)

## **10. START AND STARTING GRID**

**10.1** Cars will be placed on the starting grid in the order of times set in qualification trainings. Starting grid cars allocation will be published on notice board after the results of qualification become official. In case of flying start drivers are driving in pairs, the starting signal is the moment when the instantly red lights go off and green go on.

In case of standing start riders are standing on their starting grid slots, and the start signal is the moment when the red lights go off.

**10.2 All races apart from Endurance have standing start.**

## **11. SIGNALING AND DRIVERS BEHAVIOUR**

Drivers have an obligation to obey track marshals signals, with the special caution to the yellow flags driving. Every driver who causes danger on track or causes the need for the rescue TEAM action will be reported to the Chief Steward who may impose a penalty on such a driver.

The Speer limit in pit-lane and Road to Bowes is 60km/h. Speeding will be penalized according to art.18.1.9. of the Polish ASN Polish Touring Car Championships Regulations.

## **12. RACE QUALIFICATION**

To qualify for the race of FIA-CEZ driver has to complete at least 3 laps with time-keeping, and record the one lap time below 130% of the fastest lap time of the best driver in class.

To qualify for Polish Championships driver has to complete at least 3 laps with time-keeping, and record the one lap time below 130% of the fastest lap time of the best driver in class..

To qualify for Endurance driver has to complete at least 3 laps with time-keeping, and record the one lap time below 145% of the fastest lap time of the best driver in class..

## **13. CLASSIFICATION**

Race classification is in accordance with the rules of the Polish ASN Touring Car Championship for 2010 art.16.7

In Endurance the classification is in accordance with art. 11. of Polish ASN Endurance for 2010r.

## **14. PROTESTS**

Protest must be in written form with the deposit according to art.21. of Polish ASN Touring Car Championships for 2010. In case of the protest being acknowledged the deposit will be returned. Protests regarding Events during the race must be issued not later than 30 minutes after the results will be published.

**Protest must be addressed to Clerk Of The Course.**

## **17. OTHER INFORMATIONS:**

### **17.1. PASSES**

During administrative check driver becomes the passes for himself and for members of his TEAM. The passes shall be wearing in visible manner.

### **17.2. ADVERTISING**

All matters concerning the advertising are conformed to the relevant articles of the national and international regulations.

### **17.3. INSURANCE**

All drivers, including foreign drivers must have „Green Card” for their cars and personal insurance. The insurance must include third-party insurance and personal accident insurance.

17.4. Participation in PTCC, Endurance, Formula 2000 and Cee'd LOTOS CUP and Skoda Octavia Cup is for drivers who have valid PZM license or other EU countries ASN license as required by regulations.

17.5. In case of the use of the PZM Transponder (AMB make) competitor must leave license for deposit. Any damage or loss of transponder will result in financial penalty – 1200 PLN / 300 EURO. Shall the transponder be not returned, the penalty for returning later than on the final day of race – the penalty is 500PLN / 125 EURO.

17.6. Competitors are obliged to use a protective sheet in car service places (Art.22.1 Polish ASN Touring Car Championship WSMP 2010).

17.7. It is forbidden to drive a car or make any engine works:

- Wednesday 26th May 2010 from 20.00 to 27<sup>th</sup> May 2010 to 8.00
- Thursday 27th May 2010 from 20.45 to 28<sup>th</sup> May 2010 to 6.30
- Friday 28<sup>th</sup> May 2010 from 20.30 to 29th May 2010 to 7.00
- Saturday 29th May 2010 from 20.30 to 30th May 2010 to 7.00

17.8. Curfew 22.00 – 6.00.

17.9. Any non-sport behavior of the drivers and their teams on Racetrack „Poznań” will be financially fined by the Clerk Of The Course.

17.10. Campings

Organizer will set a place for campings.

## **18.FINAL PRESCRIPTIONS**

All matters not described in this SR are regulated by ISC and ASN Regulations. Each participant of the event by the fast of entering for the event, confirms that he acknowledges the regulations and that he will obey the rules and bulletins of the organizer published on the notice board.

Participant is obliged to obey the orders of the Officials. Organizer reserves the right to make changes to this SR and Timetable of the event.
